Description and Rationale for Recommended Action (attach additional pages if needed, this description will be shared at all levels in the University, and the University System and SACS Offices): The women's studies advisory board voted to make this name change that reflects international trends in the field. In Women's and Gender Studies we study women and men, the relations between women, between men and between the two from a feminist perspective. From one perspective, studying women, women's history, women's literature, women's lives, necessarily involves comparative analysis of what has been the dominant focus of all study in academia – men. Some believe it impossible to discuss women as separate from social practices such as power inequities, differences in roles, etc. Gender studies allows us to look at interpersonal and societal practices that create or construct women's and men's behavior and to look at men as equally gendered and socially constructed. More and more people are coming to believe that gender, like race, is a social construction, and studying the full interactions, implications, and history of gender is a part of most courses previously called "women's studies."
